SVA SCHOOL BUS REGULATIONS

The right of all students to ride the Spring Valley Academy school bus on a regular basis is conditional on their good behavior and observance of the following expectations. Any student who chooses *to not observe* these expectations will be reported to the Principal or Vice-Principal and may be suspended from the regular use of the bus and/or asked to find other transportation to school.

- 1 The school bus driver is in charge of the bus and the students. Students are expected to obey the driver cheerfully and promptly.
- 2 Students shall be on time; the school bus cannot wait for someone who is not ready when the bus arrives.
- 3 Students shall occupy the seat/space designated for them by the driver when one is assigned.
- 4 Students are to respect the rights of other students and are not to harass another student --either physically or verbally.
- 5 Spitting on the bus or out the windows is against health and safety rules.
- 6 Paper and other trash is to be placed in the trash can ---*not on the floor!*
- 7 Vandalism of any type on the bus will result in the immediate suspension of the privilege to use the bus.
- 8 Safety requires that students keep all body parts inside the bus--not outside the windows!
- 9 Students are to remain in their seats except when getting on or off the bus.
- 10 Students are to leave the school bus *only* at their designated stop unless arrangements have been made in the school office.
- 11 Courtesy and respect is to be demonstrated at all times to the bus driver, the other students, and persons along the route. Profanity of any type on the bus or out of the bus windows will result in the immediate suspension of the privilege of using the SVA school bus.
- 12 Food and gum are not permitted on the bus without the express permission of the driver.
- 13 Students shall not throw anything out of the bus windows.
